Acting Dean named for UW School of Dentistry

Dr. James C. Steiner, associate dean for curriculum and instructional resources, has been named acting dean of the University of Washington School of Dentistry, effective July 1, 2001. Dr. Paul B. Robertson, dean since 1992, announced last year his intention to step down at the end of June. He will remain at the UW School of Dentistry on the faculty in the Department of Periodontics.

Dr. Steiner is a clinical professor of endodontics and also holds the Washington Dental Service Endowed Chair. He has had a long and distinguished career in both academic dentistry and private practice.

Among other interests, he has been instrumental in developing the School of Dentistry's new simulation laboratory and in teaching students about effective ways to run dental practices.

Dr. Steiner first came to the UW in 1963 for postgraduate training in oral biology and endodontics, earning an M.S.D. degree. He had previously graduated from the College of Wooster, in Ohio, and earned his dental degree from Western Reserve University. After completing his training, he was a faculty member at the University of Washington from 1966 to 1971.

He left the UW to lead the endodontics section at Louisiana State University, and then set up a private practice for twelve years. In 1986, he moved to the University of California, Los Angeles, as head of their endodontics program. He returned to the UW in 1992 and became a clinical professor in 1997. He has held the Washington Dental Service Chair since 1998 and has been associate dean since 2000.

Dean's Column

We can be very proud of the excellence of our School, its faculty, and its superb students. Our students continue to excel on both the national and regional boards. They scored 6th in the nation on Part I of the national boards, 2nd on Part II, and all passed the Western Regional Boards. In fact, one dental examiner told the Dean that he was particularly impressed by our students' professional attitudes, clinical skills, and abilities.

We have a number of changes among the faculty. I am pleased to announce that Dr. Gerald Glickman has joined the faculty as Chair of the Department of Endodontics. He took over this past August for Dr. Gerald Harrington who retired in June 2001. Dr. Glickman plans to restructure the Graduate Program in Endodontics in order to conform to new board standards recently implemented. He also plans to include rotary instrumentation in the pre-doctoral curriculum.

Dr. Murray Robinovitch, Chair of the Department of Periodontics for the past four years, announced that he will retire in 2002. Prior to being named Chair of Periodontics, Dr. Robinovitch served as Chair of the Department of Oral Biology for more than 15 years. A search committee has been appointed and the search for a new Chair begun.

Dr. Peter Domoto, Chair of the Department of Pediatric Dentistry since 1976, has also announced that he will retire in 2002, so we will be searching for a new Chair of Pediatric Dentistry.

Dr. Eugene Natkin was recently named the first Rothwell Distinguished Teacher. The award, which is accompanied by a check for \$3,500 was presented to Dr. Natkin at the Faculty Retreat by Dr. Patricia Rothwell. The award was made for his many years of contributions to teaching at the pre-

doctoral, post-doctoral, and post-graduate levels.

Your School of Dentistry continues to be a leader among leaders in research. We recently received word that the School has been awarded a federal grant to create the Northwest/Alaska Center to Reduce Oral Health Disparities. The principal investigator is Dr. Peter Milgrom, and the School will receive \$10,000,000 over the next seven years.

The School also has received \$320,000 from UW Provost Lee Huntsman to develop architectural plans for the remodel of the B-Wing. This represents the first step in obtaining funds to accomplish this critical goal. The B-Wing has had only minimal upgrading since its construction in 1950!

Our students continue to be very active professionally. They hosted the very successful western tri-regional meeting of the American Student Dental Association last spring. As a result of contributions to a new Dental Alumni and Friends Fund for Students, we were able to send 3 students to the American Dental Association meeting for the first time.

Your contributions for student activities and scholarships will become more and more important over time as the cost of dental education increases. As a result of the current budget crisis in the State, there is some discussion about increasing professional school tuition at the UW. Of course, that raises huge concern about access to professional education.

I enjoy working for you as Dean of your School. If you have not visited the School lately, I encourage you to stop in for a tour and to talk to our students. I am confident that you will be rewarded for the effort. I hope you will stop by to see me when you are here.

DENTAL MATERIALS AND THE PRACTICING DENTIST

Jack I. Nichols, Ph.D.

The expanding field of restorative materials used in the dental office has led to a rather alarming number of products available in all categories. Manufacturer claims propose that their individual product is far superior to the competitor equivalents. This seminar will cover three product areas which are receiving a considerable amount of attention both in dental publications, and manufacturer produced literature.

The morning session will be devoted to two separate product lines, (a) the resin dental adhesives and (b) the newer dental lights.

The dental adhesives will be discussed in terms of:

- (1) the individual handling steps required for the several categories
- (2) current information on bond strengths to both dentin and enamel
- (3) suggested steps for checking the effectiveness of the adhesives
- (4) recommendations on which products to use in the operator

The newer dental lights will be covered in terms of

- (1) the array of products available
- (2) is any light system better than the others
- (3) do the newer light programs (eg ramp, step or modulated) really help
- (4) recommendations on which products to purchase

The afternoon session will be devoted to the newer post and core systems, and rebuilding the compromised endodontically treated tooth.

Discussion here will cover:

- (1) defining the current array of posts available
- (2) defining the array of core materials available
- (3) recent research covering the strength of the rebuilt tooth
- (4) clinical procedures leading to a stronger union between tooth and crown

Dr. Eugene Natkin Presented with First Bruce R. Rothwell Distinguished Teacher Award

Dr. Eugene Natkin, professor emeritus of endodontics in the University of Washington School of Dentistry, has received the first Bruce R. Rothwell Distinguished Teacher Award.

The new Bruce R. Rothwell award honors one or more faculty members who have made significant contributions to the teaching program in the School of Dentistry. Dr. Rothwell joined the UW faculty in 1974. He was chief of service of dentistry-oral surgery at University of Washington Medical Center and director of hospital dentistry from 1989-2000. He was appointed chair of the Department of Restorative Dentistry in 1993, a post he held until shortly before his death on November 14, 2000, at the age of 52.

In recognition of his many contributions to teaching, his widow, Dr. Patricia Rothwell, and friends and colleagues established the award. The award, presented to Dr. Natkin during the annual faculty retreat in August, was accompanied by a check for \$3,500.

"Gene Natkin is the teacher of teachers. The method developed by Dr. Natkin for teaching courses in endodontics enabled young faculty members... to quickly establish themselves as effective teachers and to become recognized early in their careers with numerous student awards for teaching excellence. As a consequence, the teaching program developed by Dr. Natkin has earned the department an outstanding national and international reputation," says Dr. Gerald W. Harrington, who nominated Dr. Natkin for the award. Dr. Harrington is a professor emeritus, and former chairman of the Department of Endodontics.

Dr. Harrington said that Dr. Natkin's former graduate students have gone to become deans, associate deans and numerous department chairs and graduate program directors. Dr. Natkin

earned his DDS degree from New York University in 1957, followed by his MSD from the UW in 1962, when he became the first graduate of the specialty program in Endodontics. His self-instructional syllabi, developed with Dr. Robert Guild, have been widely recognized for the quality of instructional material. Many of the concepts put forth, unpublished at the time, proved to be ahead of their time in predoctoral and postdoctoral educational programs.

Dr. Natkin chaired the department until 1980, also the year he became a full professor. In 1995, he retired from his full-time appointment, and was made a professor emeritus.

"His approach was to reduce complex concepts to a level readily understood by the neophyte clinician," Harrington said. "As a means of simplifying the teaching, and therefore the understanding, of pulpal and periapical diagnosis, he developed reasonable and useful clinical categories which subsequently have been adopted almost universally."

The selection committee for the award included faculty members Drs. Patricia Rothwell, Paul B. Robertson, Mark Drangsholt, Karen Sakuma, Heidi Horwitz and Robert Nieman, as well as Betty Low, administrator of the Department of Restorative Dentistry.

22 Dental Students Awarded \$1.6 Million in National Health Service Corps Scholarships

Twenty-two students (17 third-year students and 5 fourth-year students), attending eleven different dental schools have been offered new scholarships awards valued at \$1.6 million from the National Health Service Corps (NHSC) for the 2001-2002 school year.

Awardees will receive full educational scholarships during their junior and/or senior years of dental school in exchange for a commitment to provide primary care oral health care services for a minimum of two years in an underserved community identified by the NHSC.

Henry Stuart Kendall Willis (class of 2003) at the University of Washington was one of the scholarship recipients selected.

Six UW Dental Students Attend ASDA National Conference in Orlando.

UW Receives ADPAC School of the Year Award.

The 31st Annual Session of the American Student Dental Association was held in Orlando, Florida on August 28-September 2, 2001. Among the attendees were six students from the University of Washington School of Dentistry. The six student delegates were Sean Couch (1st Delegate), Nathan Russell (ADPAC Representative and 2nd Delegate), Eric Nordstrom (Alternate Delegate), Timothy Gatten (Legislative Liaison), Eric Kvinsland (Legislative Liaison), and David Newell (Alternate Delegate). There were 265 ASDA delegates attending the meetings, representing all 52 dental schools.

Throughout the week, students heard from ASDA's leadership and its respective task forces and committees. The main focus of the five day meeting was to elect a new Executive Committee, Board of Trustees, and to conduct the business of ASDA's House of Delegates. Washington's Dr. Terry Grubb, ADA 2nd Vice President, is the ADA board liaison to ASDA and

addressed the students as well. ASDA's task force on dental licensure reform gave its annual report. Our most current victory was the adoption of a resolution by the ADA to eliminate live patients from clinical licensure exams. In addition to licensure reform, members were updated on many diversity issues, membership and marketing concerns, as well as other governance and professional issues relating to students and dentistry. Members also were applauded for their effort in the expansion of student loan interest deduction, which was signed into law on June 7th by President Bush. The lobbying efforts of ASDA members claims a share of the credit.

During ASDA's legislative sessions on Friday, several speakers addressed the delegates regarding political advocacy and the need for involvement. Speakers included Nathan Russell (Student ADPAC Representative from the UW), Mr. Michael Graham (Senior Congressional Lobbyist, ADA), and Dr. Samuel Selcher (ADPAC, District 3

Dr. Gerald N. Glickman has been named chair of the Department of Endodontics and Director of Graduate Endodontics at the University of Washington School of Dentistry. He replaces Dr. Gerald W. Harrington who retired on June 30 after 32 years of service to the Endodontic Department and the School of Dentistry.

Dr. Glickman came to the Department of Endodontics from the University of Texas-Houston Dental Branch where he was Chair of the Department of Stomatology and Director of the Advanced Education Program in Endodontics. He is a Diplomate of the American Board of Endodontics and is currently a Director of the American Board of Endodontics.

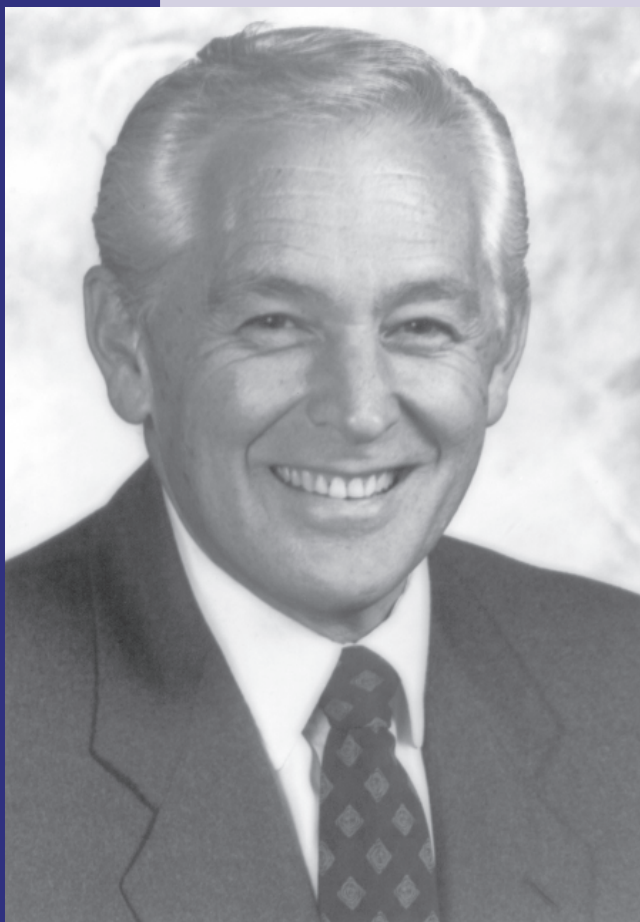
Dr. Douglass graduated from the University of Washington in the class of 1969 and then received his certificate in Periodontics in 1973.

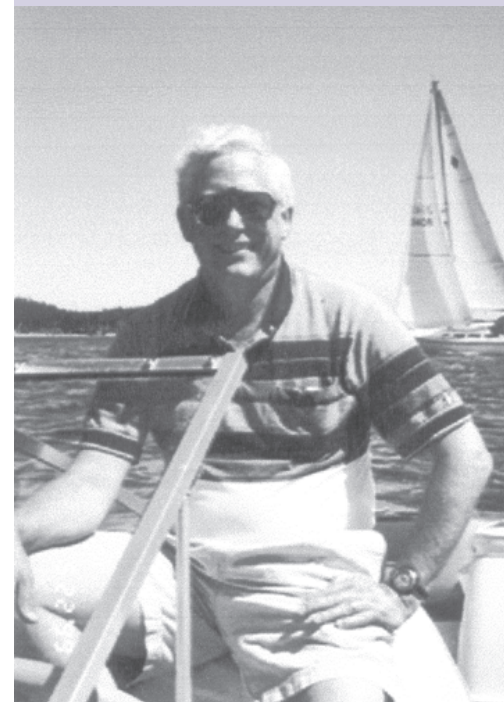
