# CDE in New Sim-Lab a Hit With Alumni

Last winter, the School of Dentistry began offering CDE courses in the newly remodeled preclinical simulation laboratory. Alumni who participated in these courses praised the new pleasant surroundings and the vastly improved lighting and layout.

In January, Drs. Dennis A. Shanelec and Leonard S. Tibbetts (perio, '69) taught a course on periodontic microsurgery with microscopes provided by Global Surgical Corp. The course focused on the basics of wound closure, with specialists and grad students practicing the procedures after they were demonstrated. According to one participant, Dr. Jeanne Bertino (perio '79), "The experience of hands-on learning in a modern, clean, and collegial environment was exhilarating. Using simulators will make future courses more feasible, effective, and stimulating."

In February, Dr. Karl R. Koerner ('73) taught "Difficult Oral Surgery." Using

custom dentoforms, participants learned to extract an impacted third molar and to perform a socket graft to preserve alveolar ridges on the lab's new simulated patients.

Dr. Koerner's course was repeated in April after the new computer-assisted instructional equipment was installed. With the new equipment, Dr. Koerner was able to demonstrate a new suturing technique while participants watched on their own high-resolution monitors.

Dr. Neil Bergstrom ('73), a participant in the course, was very impressed with the pleasant atmosphere in the new lab.

According to Dr. Bergstrom, "Working in the simulation laboratory is a very enjoyable experience - much improved from the cramped and dim labs of the past."

Dr. Koerner remarked, "The new simulation laboratory is the finest facility of its kind in the country. The UW is ahead of other dental schools with its visionary learning lab."

Now alumni may benefit from the new state-of-the-art laboratory too.

#### President's Message

This year has passed swiftly and the Dental Alumni Association has had many accomplishments. The D-l laboratory campaign is on going with \$625,000 contributed to date. The Association decided that on the 50th Anniversary of the first graduating class of the Dental School, in the spring of 2000, the alumni would donate one million dollars to the dental school to fabricate a modern technique laboratory for the pre-clinical students. These modern simulators, coupled with computers and audio visual aids, will be extremely advantageous for the students at the University of Washington Dental School and can also be used in continuing education classes.

The reality is that many dentists in the first graduating classes are either no longer with us or have retired from practice. The donations from these classes have been less than anticipated. The classes that have graduated in the last decade do not have the financial wherewithal to donate as much as they would like. This leaves the rest of us to take up the slack.

It was the goal of the Dental Alumni Association to raise \$20,000 from each class. With 50 classes that equals one million dollars. There are fifteen classes that have either reached, or are very close to their goal. The other classes need to step up to the plate and finish the job. The donations are vital to the School.

We now have a membership category for retired alumni dentists who have retired from active practice but still want to keep in touch with the UW Dental School through the Dental Alumni Association. More details will be coming about this new category.

The Ernie Jones lecture was presented by the endodontic department in March and was outstanding. Dr. Gerald Harrington, Dr. James Steiner, Dr. David Pitts, and Dr. Mark Freeman gave a marvelous presentation on endodontics. I overheard a conversation between two dentists saying they didn't think "dental insurance" can be convinced to cover the treatment that is indicated. My opinion is that our time spent out of our offices learning correct techniques should not be wasted. It is our obligation to convince our patients that prepaid dental care plans are not a criteria for diagnosis. It should be the patient and doctor that determine treatment. The patient should be presented with all the details regarding what is needed to maintain the tooth in optimum

dental health and the patient should then decide. The second comment that I heard was that the Alumni Association is often asking for money. It is a fact that we often do ask for money. It is in the charter of the Alumni Association, and in our constitution, to further dental education at the University of Washington Dental School. Many of us cannot teach at the University of Washington due to distance or other time commitments, but we can certainly give money. We should be proud our dental school is considered one of the best in the country and the students that it is graduating are doing well in every aspect of dentistry, including research, public health, dental education and private practice. We should be proud to be members of our Dental Alumni Association and to help the Dean with an additional funding source for quality programs, as we are doing with the D-l Lab project.

I would like to give special thanks to Dr. Mark Grace for his work on the membership committee. He has also accepted responsibility for becoming secretary of the Association, which means he will ultimately become president. Mark has several events planned. An evening of baseball with the Mariners will be held on September 18th for the classes that have graduated in the last decade. This is hoped to instill a feeling of belonging to the Alumni Association. Dr. Jacka has organized the first annual Alumni Association golf tournament. It will be held at Druid's Golf course in Kent on October 1, 1999. Dr. Sam Anderson has thrown down the gauntlet and said his class's foursome will beat all comers. If any other class would like to take up the challenge I'm certain that can be arranged.

I would also like to thank Sue Corbett, Randy Newquist, Kristin Larson and everyone else at the Alumni Association office at the School who have made this year easier. I have enjoyed being the President of the Dental Alumni Association and look forward to working with our incoming president, Dr. Carrie York; president-elect, Dr. Ross Fraker; secretary, Dr. Mark Grace; and treasurer, Dr. Don Lederman.

The 29th Annual Ernest M. Jones Memorial Lectureship was held on Friday, March 26, 1999. "Topical Issues in Clinical Endodontics," was presented by four UW Endodontic Department Faculty. Dr. James Steiner (the first WDS Endowed Chair), Dr. Mark Freeman, Dr. David Pitts, and Dr. Gerald Harrington presented the well received and enlightening lecture.

This year's lecture drew 350 dental alumni, dentists and dental co-professionals to Hogness Auditorium in the School of Dentistry. Dr. Dexter Barnes (Class of 1969) was chair of the event again this year. Restoration of compromised teeth, modern apex locators, rotary instrumentation, vertical root fractures, and extracanal invasive resorption were some of the topics covered. In conjunction with the lecture, 125 alumni attended the Annual Dental Alumni Association luncheon meeting held in the Don James Center at Husky Stadium. Dean Paul B. Robertson gave a "State of the School" address and the incoming officers for the 1999-2000 year were officially approved as: President: Carrie York (Class of 1991), President-Elect: Ross Fraker (Class of 1980), Secretary: Mark Grace (Class of 1994), and Treasurer: Don Lederman (Class of 1961). They will begin their terms of office on July 1st.

#### Dean's Column

I was recently asked to support the nomination of the Washington State Dental Association for the Golden Apple Award for Achievement in Dental School/Student Involvement in Organized Dentistry. I was pleased to do so as the School of Dentistry is substantially enriched by participation of the WSDA in essentially all of its academic programs. At the same time, I was reminded of the importance to great Schools of Dentistry to maintain a strong relationship with organized dentistry in its broadest context. Students at the University of Washington School of Dentistry are among the leaders in the nation for entry level GPA, scores on National Boards, performance on State and Regional Boards, involvement with the community, and a solid commitment to organized dentistry. This record of student achievement is due, in great measure, to the collegial and mutually beneficial relationship between the School of Dentistry and the American Dental Association, in general, and the WSDA and it's Component Societies, in particular. Moreover, the strengths accrued through these interactions are multiplied by relationships with the International and American Colleges of Dentistry, the International and American Associations for Dental Research, the Pierre Fauchard Academy, and other professional organizations committed to excellence in Dentistry.

The ADA provides a variety of programs of direct benefit to students and faculty. ADA's recent support and participation in the Northwest Dental Student Conference is one of the many examples of the consistent concern for students and new professionals. By the same token, many of our faculty serve on ADA committees and councils. It is also interesting to note that faculty from UW have recently served as presidents of the International and American Colleges, and the International and American Associations for Dental Research.

The School is especially fortunate to enjoy a unique relationship with the Washington State Dental Association to promote an early and positive interaction with students. The Mentor Program assigns a practicing member of the WSDA to each incoming first year dental student. The WSDA mentor remains with the student throughout his/her four year dental program. The program creates a strong connection between dental students and the practicing dental community; supports and encourages young dentists during their dental school years and helps educate them in areas of professional development; and increases student awareness of the importance of organized dentistry. The Mentor program has been an overwhelming success. Student evaluations of the program praise the dedication of individual mentors, the contribution of mentors to high standards of excellence in both technical and professional disciplines, invaluable assistance in understanding treatment approaches, and a clearer view of practice management and ethical behavior. As important, students note a sense of belonging to the profession from the day they enter the dental program.

The WSDA Committee for Liaison with the UW and New Dentists has also made outstanding and continuing contributions to the School throughout my tenure. The Committee maintains a solid link with faculty, students, and the Dean; establishes programs in connection with the Washington State Board; promotes potential sources of financial support for students; and carries out recruitment and retention activities with special emphasis on the young dental professional and quality candidates who reflect the demographics of the population. There is a strong and highly positive relationship between the American Student Dental Association and the WSDA Liaison Committee who jointly sponsor many programs, including annual tours of WSDA practices (Suite of Dreams), the Pacific Northwest Dental Student Conference, faculty and student leadership awards, and student participation in WSDA meetings.

Members of the WSDA actively participate in many of the School's committees and constitute the heart of the Admissions Committee which selects our incoming students. The WSDA has been a strong supporter of the Dean's Club and Alumni Association initiatives. Conversely, the majority of UW faculty are members of the WSDA and serve in the WSDA House of Delegates and on the Executive Board. Despite a state law that precludes automatic student membership, essentially all of our students are ASDA members. They are welcomed at WSDA activities and a very high percentage join ADA upon graduation. As a Dean and long-term member of the American Dental Association, I cannot sufficiently express the importance of organized dentistry to the School of Dentistry. Relationships with the WSDA have been particularly rewarding and the School is far better for their support and counsel.

# 1999 Distinguished Alumnus Robert L. Flennaugh, D.D.S. (CLASS OF '64)

The University of Washington Dental Alumni Association has selected Dr. Robert L. Flennaugh as the seventeenth recipient of its Distinguished Alumnus Award.

The purpose of the Award is to recognize individuals who by their professional achievements and contributions have distinguished themselves, have enhanced the profession, improved the welfare of the general public, and have brought honor to their Alma Mater. As such, the Award reflects contributions made over a long period of time and not single outstanding achievements.

Dr. Flennaugh was born in Bakersfield, California, attended grade school and was a farm worker in the San Juaquin Valley, attended



Merced Union High School one year before he and his family moved to Fairbanks, Alaska. In 1955 he graduated from Fairbanks High School as President of his graduating class and attended the University of Alaska before transferring to the University of Washington to complete his pre-dental studies. As an undergraduate he played the saxophone with the UW Marching Band and led the band as the Drum Major during the 59' football season and at the Rose Bowl games of 1960 and 1961.

Dr. Flennaugh graduated from the UW School of Dentistry Class of 1964 and following graduation established his dental practice in the First Hill area of Seattle which he maintains at present. In 1968 he returned to his Alma Mater to teach part-time in the F.P.D. lab which he enjoyed working with the students while contributing to the shaping of their dental skills and philosophy.

Dr. Flennaugh was appointed to the University of Washington Board of Regents in 1970 and elected President of the Board in 1975. He completed one 6 year term and one year of a second term before he was appointed to the Council on Post-Secondary Education in 1977.

Dr. Flennaugh has always been very active in community affairs. He served as President of the Board of Directors of Seattle-King County Planned Parenthood. He is the Past President of Zeta Pi Lambda Chapter of Alpha Phi Alpha Fraternity, has served on the Board of the University of Washington Friends of Educational Opportunity and the Alumni Fund Board. In addition, he has served on the University Hospital Board, Seattle Community Health Board, Carolyn Downs Family Medical Center, the Seattle Model Cities Advisory Board, and as a volunteer dentist for the Seattle Indian Health Board Dental Clinic. Dr. Flennaugh served ten years on the first Board of Directors of the Washington State Convention and Trade Center.

In the past, Dr. Flennaugh has served at First African Methodist Espiscopal Church, Seattle as a choir member, choir Director, usher and high school class teacher. He is currently serving as the Church School Superintendent and Chairman Pro tem of the Board of Stewards. He has served eight years with Bible Study Fellowship as a Teaching Leader for the Seattle Evening Men's class before being appointed to his current position as Area Advisor for twelve Bible Study Classes in Washington, Oregon, and Idaho.

Dr. Flennaugh is currently serving as the dentist for the Seattle Seahawks Professional Football Team, a position he has held since 1976. He is also currently serving on the Board of Trustees of CRISTA Ministries.

Dr. Flennaugh and his wife Bernice were married in 1963 and are the very proud parents of Robert L. Flennaugh II, a graduate of the UW School of Law, and Damon E. Flennaugh, a graduate of the UW School of Aeronautics and Astronautics.

The award will be presented to Dr. Flennaugh at the Dental Alumni Association All Classes Reunion at the Washington Athletic Club in Seattle on Friday, July 16th during the Pacific NW Dental Conference.


# School of Dentistry Celebrates

The Jack E. Nichols Student Leadership Award was established in 1994 to recognize and reward student leaders within the School of Dentistry with the hope of inspiring students to continue in leadership roles throughout their professional careers. David was the 1999 Northwest Dental Student Conference Steering Committee Chairperson, the Editor-in-Chief of the UW ASDA chapter newsletter from 1996-98, the Dental Student Research Group Officer-at-Large from 1996-97, and the Dental Student Research Group Fellowship Coordinator from 1997-98. In addition, David served as the 1999 Peer Group Advisor to the class of 2000 and as the University of Washington's ASDA liaison to the Washington State Dental Association. David is sure to be a leader in dentistry for many years to come.

The final award presented was The Dean's Club Honorary Lifetime Membership Award. Presented annually to the person who provides the most outstanding service to the School of Dentistry, this year's winner is Dr. David H. Wands. Dr. Wands, a former faculty member at the School, recently established a fellowship in graduate prosthodontics with a gift of \$400,000 (an additional matching gift of \$100,000 is being offered by the State of Washington). The Wands Fellowship will help the School to recruit outstanding scholars and clinicians into the Graduate Prosthodontic Program, and will encourage recipients to pursue academic careers in prosthodontics. Dr. Wands is a strong proponent of giving generously to the School as a way to reduce one's federal taxes. Wands jokes, "I can't remember the last time I received a thank you note from Uncle Sam, but I will certainly remember the School of Dentistry thanking me for my gift."

# The Practice of Quality Care S. David Buck (Class of '88)

If you have any doubt that providing quality care can both guide and drive a dental practice, then you haven't met S. David Buck (DDS '88). In an age of ever-increasing insurance and managed healthcare regulations, Dr. Buck has become a hero of sorts to his clients – many of whom are blind and/or deaf. This is the story of a man with a desire to serve not only the needs of a particular community, but to provide the very best in dental care to all his patients.

A native of South King County, Dr. Buck received both his undergraduate and dental degrees from the University of Washington. He became interested in the pre-dental program through a dentist who was a close family member. When Dr. Buck's guidance counselor told him he would need at least a 3.5 grade point average in order to get into dental school, he was "scared into" working hard academically. At the same time, he put himself through school by working at various jobs throughout the year.

At the age of 19 he married, and had his first child two years later. Now the proud – and busy – father of four boys (ages 5 - 15) and one stepdaughter, Dr. Buck has coached several of his children's sports teams over the past 10 years. "The most important thing we can give our children is our time," he says. In getting to know Dr. David Buck, it becomes apparent that he brings this caring philosophy to his professional life as well.

It all started in 1989 when he met and befriended Dr. John Deines, the late past president of the American Dental Association, who had developed a practice which included

several Catholic nuns among its clientele. At the time, Dr. Buck had acquired his own practice by merging three practices into one – and was now in search of a fourth. Dr. Deines was preparing to retire and sell his practice, and Dr. Buck was studying the idea of purchasing it. In considering this opportunity, Dr. Buck learned not only of the structure of Dr. Deines' practice but, more importantly, how he had developed a reputation for integrity and client loyalty.

Dr. Buck had observed that effectiveness and efficiency are often at odds with each other. According to Dr. Buck, the move in this country toward managed care in the 1980s only amplified this reality, as care providers were forced to shift their focus from quality to quantity – from people to regulations manuals. Dr. Buck himself had witnessed how little time he was spending with his own patients. He had grown frustrated with the insurance industry and its effect on his ability to interact meaningfully with those who sought his professional services.

In contrast, Dr. Deines was oldfashioned when it came to providing care. To him, a successful practice simply meant having clients who trusted him. It meant having the freedom to establish solid relationships

with his patients so they would turn to him openly. It meant not having to treat people as numbers or as means to an end. It wasn't long before Dr. Buck decided to purchase Dr. Deines' practice and continue his legacy of putting the client first.

Dr. Buck soon discovered that in the process of building a reputation for integrity and sensitivity, Dr. Deines had developed a broad client-base, including people who were seeing- and/or hearing-impaired. Through one such client Dr. Buck was introduced to Lighthouse for the Blind, a non-profit agency dedicated to helping the seeingimpaired. Dr. Buck's newfound connection to Lighthouse lead to more and more referrals, as word steadily spread about the good work he was doing in the community.

As Dr. Buck explains, "I had to change the structure of my practice to work with this client-base, so that the environment would allow more trust and rapport to develop between my clients and staff. Since communication with these groups is more challenging, it became an exercise for the entire staff to become more empathetic and more attuned to completely understanding our seeing- and hearing-impaired patients. Understanding the needs of our patients with disabilities has enabled us to transfer this same focus on quality care to all our patients." Dr. Buck says that his seeing- and hearingimpaired patients have allowed him to concentrate on creating a clientcentered practice, one that seeks to

make all patients feel taken care of and at ease with their surroundings. "This approach takes more time," he confides, "but it's well worth it. We have established a very good working relationship with the blind and deaf communities here in Seattle."

Dr. Buck credits the redefinition of his practice in large part to the close association he has developed with a professional dental management company which focuses on effective communication skills, as well as leadership training, an example of which is Dr. Buck's mission statement:

#### Mission Statement for Broadway Dental Center

During our time together, our goal is for you to feel our complete integrity and enthusiasm. You are a unique and valued individual and we wish to offer you the opportunity to select an ideal level of health. By using bio-compatible materials that are mercury free and mimic the natural beauty of teeth, you can be confident in your health and your smile. By enhancing your life in this manner, we too are enriched by this experience and through the lasting relationships we develop. But most of all, we have left this world a better place than when we started.

Quality over quantity is a recurring theme when talking with Dr. Buck about his philosophy of care. He sees no more than five to seven patients a day, moving each one from start to finish in the same treatment room. Dr. Buck's approach to care honors the





individual; timeliness, scheduling no more than one patient at a time, and active listening are all key to the success of his practice. Dr. Buck points to surveys of patients' priorities that demonstrate a strong desire for dentists to listen, to be on time, and to respect the concerns of the patient. Price, it turns out, ranks near the bottom of the list.

At the heart of Dr. Buck's philosophy is his belief that doctor and patient can and should form a partnership. In such a relationship, the doctor asks the client about their goals, desires and expectations; the doctor seeks to know what is important to the individual, and only then develops a treatment plan. This experience, says Dr. Buck, empowers both parties: "The joy on my patients' faces says it all. It's amazing how appreciative people can be."

# Three UW School of Dentistry professors receive international awards

Three professors from the University of Washington School of Dentistry were recipients of international awards at the opening of the 77th General Session of the International Association for Dental Research (IADR) held in Vancouver, BC on March 10.

The 1999 Research in Oral Biology Award was presented to Beverly Dale-Crunk, for outstanding research in epithelial differentiation. She is particularly renowned for her discovery and characterization of a unique filament-aggregating protein involved in keratinization. Dale-Crunk and her colleagues have developed systems for growing oral and junctional epithelium in vitro and for examining differentiation in this system. She is also director of the institutional Dentist Scientist Program at the UW. Dale-Crunk earned her bachelor's and PhD degrees from the University of Michigan and joined the UW in 1972.

The 1999 Craniofacial Biology Research Award was given to Susan W. Herring, professor of orthodontics and zoology, who is renowned for her work in morphology, particularly muscle-bone interactions. Many of her methods and concepts derive originally from vertebrate paleontology. Her most recent work has brought the concepts, databases and techniques of allied fields to craniofacial investigation. Herring received her PhD in anatomy at the University of Chicago.

The recipient of the 1999 Behavioral Sciences & Health Services Research Award was Peter Milgrom. He is best known for creating the first clinic in the world for patients with dental fears and is recognized as one of the international authorities in the field. He has served as the principal investigator on numerous grants to investigate the epidemiology and treatment of dental fear in adults and children. Milgrom is currently studying the efficacy of combining benzodiazepine tranquilizers with a behavioral treatment for the clinic's patients. He received his dental degree from the University of California-San Francisco in 1972 and has been a member of the faculty since 1974. Dr. Milgrom also received the 1999 Giddon Award for the best research paper in the field for his work on increasing access to dental care for children from low income families.



# UW Recognizes First-Year Students



Asian/Pacific Islander Student Award

#### Thai Nguyen

In the months immediately follow-

ing the war in Vietnam, Thai Nguyen's family twice tried and twice failed to escape from the country by boat. For the opportunity to try to escape-those who were desperate to leave the country paid in gold. Families spent years accumulating and hoarding gold jewelry and coins. The Nguyen family's two failures to escape cost them not only their gold but several months in a jungle prison camp.

Years later, when they were permitted to leave and finally arrived in the United States, Mrs. Nguyen was suffering from cancer, the family was impoverished, and none of them could speak English. Within two weeks of their arrival, Thai-who was 16 and the oldest of the Nguyen's two childrenwent to work as a bag boy at a Safeway store in Kent to help support the family. By the time he was nineteen and a student at the UW, he had become the store's bookkeeper. During his UW years he has taken the hourlong bus commute from home to campus and back, and worked at Safeway three nights a week from 4:00pm until 2:00am.

In his first two years at the UW, he worked with patients in Physical Therapy at the UW Medical Center.

His breakthrough experience came when, as a sophomore, he worked in Thoracic Cardiac Surgery, in the Department of Surgery's Transplant Division, where he learned microsurgery and discovered that he had the good hands of a surgeon.

Dentistry appealed to him more than the other health sciences. He is drawn to the basic science, the craftsmanship, the involvement in diagnosis, treatment and prevention, and the opportunity to create an independent business. He was offered admission to the schools of dentistry at Tufts University, in Boston; Temple University, in Philadelphia; and the University of Washington. He started at the UW (Class of 2002). His scholarship award is \$1000.



Student Support Services Award Ryan Kezele

Ryan Kezele, who grew up in the

Yakima Valley, has attended the UW on a scholarship from the Chickasaw Nation. His great grandmother, reportedly the last full-blooded Chickasaw tribal member, left Oklahoma for eastern Washington during the Great Depression. She was a single parent with seven children. What she left in Oklahoma was a dollar-a-day cotton-picking job, and what she found in the Yakima Valley was a step up in orchard and warehouse work. Her children and her children's children settled into the Valley, raised families, and like the great grandmother, made their living in the fruit industry. When she was a young woman, Ryan's mother left and went to work in the Bremerton shipyards. Ryan moved back to the Valley as a teenager and graduated from high school there, where his father worked for the Yakima tribal irrigation authority.

He is the first in his family to go to college. The lessons from three generations of family hardship were not lost on his mother, who became Ryan's education mentor and he credits her with seeing to it that he didn't stray off the road that finally led to the UW.

After high school, he entered Yakima Valley Community College to save money and be near his seriously ill father. In 1995 he transferred to the University of Washington.

Ryan's career path has been leading to the health sciences for a long time. He got started in that direction from summer experiences back in the Yakima Valley, first at an Indian Health Service Clinic and then at a Yakima farm workers clinic and finally in a family dental clinic.

He earned a degree in Biology and now has been admitted to the University of Washington School of Dentistry (Class of 2002). His award is \$1,000.



"Dick Roos was a man who gave constantly- to his family and to his profession. He always felt he needed to give something back to dentistry, in view of the fact that it had provided to his family, and from this, he decided he would give a lot of his time both to teaching at the University of Washington (as mentioned above) and service to the Snohomish County Dental Society.

Dick had many passions, but two that stand out as the most discussed were fishing with his peers, and being at his Whidbey hideaway. When June arrived each year, he was ready for his annual fishing trip to Canada with a dental study group that had been making this trip for many years. And on his return, the stories were all about the "big ones" and where they were caught. To say that he had very





relaxing times here is without question, but, his times at the cabin on Whidbey were not to be underscored. He loved this place, and spent as much time there as he could. Generally on the weekends. And a very "blackened" and somewhat humble Dick agreed that a repair man was in order. The fact that Dick died alone in his Whidbey cabin is tragic, but not really so sad. He passed away in a place he loved, with memories of past years around him. In this place he raised a family, had extremely happy times, and memories that will never be lost. Would it have been better for this to happen in a hospital bed with strangers around? I think not. Dick would have preferred it this way, in his Whidbey hideaway."
