LAW/LEWIS LECTURE IN PEDIATRIC DENTISTRY**PEDIATRIC PATHOLOGY: MOST COMMON ORAL DISEASES IN CHILDREN**

SEATTLE

This course is designed for specialists, dentists, dental hygienists and dental assistants.

This course is collaboratively taught by two experienced clinicians: an oral surgeon and an oral pathologist. Their combined experience results in a well-rounded, complete course that discusses the full arc of diagnosis and treatment of pediatric oral diseases: identification of these diseases from the early stages, treatment and post-treatment management of patients.

This course will cover the most important and most common pediatric oral diseases, as well as some uncommon but problematic cases, especially those of bone origin. Pediatric patients include infants through young adults. The course emphasis will be on the clinical presentation, ideal management, and treatment of each disease. Each disease will be presented through clinical photographs and/or radiographs with an applied clinical differential diagnosis, followed by a complete discussion of the clinical presentation, etiology, treatment, prognosis, and complications when applicable. Broadly, this course will cover five topics: infectious diseases, oral single and multiple swellings, odontogenic cysts, odontogenic neoplasms and non-tooth related jaw bone lesions. The conditions discussed range from reactive to benign to malignant. The course will also cover non-tooth related jaw pathology, including benign fibro-osseous lesions, benign and malignant neoplasms. The goal of this course is to cover the most common diseases in children while giving dental practitioners the tools to recognize the full range of presentations, including the challenging unusual clinical presentations, of such conditions. In this course, the audience will see diseases that look benign but are, in reality, not so benign. They will also see cases that look aggressive but are benign. The spectrum of clinical presentation is wide but the approach to diagnosis is logical and consistent. Clinicians will leave this program with ample applicable knowledge necessary to improving the everyday practice of diagnosing oral diseases in children.

Course Objectives — As a result of attending this course, you will be able to:

- Identify and treat the most common oral infections in children.
- Determine which lesions need to be biopsied and which do not.
- Discuss the latest technology oral cancer treatment in children.
- Recognize common odontogenic and bone pathology in children.

ERNEST M. JONES MEMORIAL LECTURE**ALTERNATE PERSPECTIVES IN DENTISTRY: AIRWAY ORTHODONTICS**

Barry Raphael, DMD

Friday, March 23, 2018

SEATTLE

This course is designed for dentists, hygienists and dental assistants.

In an effort to think outside the box, our presentation this year delves into a topic deemed controversial by some, revolutionary by others. The lecture will deal with some techniques not espoused by the UW Orthodontic Program. It will explore research and new treatments emerging in the field of orthodontics, and their proposed effects on sleep apnea and other maladies resulting from airway issues. Our day will conclude with an opportunity to ask questions and discuss the merits and challenges of this evolving topic.

Just as all healthcare professions are struggling with the ever-increasing burden of chronic disease, we have a similar dilemma to solve in dentistry: do we deal with the symptoms of dental disease or do we deal with underlying causes?

There is a view of orthodontics that malocclusion is not the problem to be solved but is a symptom of an imbalance elsewhere in the mouth, face, head, or body. From this perspective, the basic functions of breathing, posture, nutrition, and sleep become the primary targets of therapy. While straight teeth will always be a desirable trait, straight teeth in balance with the rest of the body may become the focus of what is being called Airway Orthodontics.

Dr. Barry Raphael has been an orthodontist in private practice in New Jersey for 33 years. Eight years ago he began a transition to Airway Orthodontics that has significantly changed his practice and treatment outcomes. He will describe the rationale behind his philosophy, his expanded assessment of patients, the various treatment modalities behind his approach, and his view of the future of orthodontics. He will draw a timeline for the treatment of patients from birth to sleep apnea and how important it is for all dental and medical professionals to be involved in this endeavor.

BARRY RAPHAEL teaches these concepts at the Mt. Sinai School of Medicine, Department of Pediatric Dentistry in New York City, at the Center for Integrative Education in New Jersey, and at universities and forums in the United States and internationally. He is currently president of the New Jersey Association of Orthodontists, a component of the American Association of Orthodontists.

He has further completed a residency at Canada's largest tertiary care facility, Vancouver General Hospital, and is the current Director of Clinical Pharmacy Performance Services for VHA, living in Whitefish, Montana. He has a special interest in dental pharmacology and has lectured internationally to both dental and medical practitioners. He has spent the last seventeen years focusing on dental pharmacology and the art of dental therapeutics, and has become a leader in this field of study.

JASON GOODCHILD is a graduate of Dickinson College in Carlisle, PA. He received his dental training at the University of Pennsylvania School of Dental Medicine. Dr. Goodchild serves as Associate Professor & Chairman of the Department of Diagnostic Sciences at Creighton University School of Dentistry (Omaha, NE). Recently, he joined the Premier Dental Products Company in Plymouth Meeting, PA as the Director of Clinical Affairs. He has published numerous articles and lectures internationally on the topics of treatment planning, treatment of medical complex patients, restorative dentistry, pharmacology, emergency medicine in dentistry, enteral sedation dentistry, and dental photography. He has been an invited speaker for the Academy of General Dentistry and American Association of Dental Examiners. He is a reviewer for the *Journal of the American Dental Association*, *General Dentistry*, and *Quintessence International*. With the baby boom generation reaching 65 years and beyond, this is the first generation of Americans to reach older adulthood with an almost intact natural dentition. While keeping our teeth as we age is a positive trend, increasing lifespans can also result in the onset of chronic conditions, long-term medication usage, and oral diseases that can create complex dental treatment needs and questions on the part of dental professionals on how to care for this population.

Most dentists today received very little formal training in caring for the unique needs of older patients. The Arcora Foundation engaged a team of national experts in serving older adults, led by Dr. Linda Niessen, DMD, MPH, to develop a course that discusses the importance of treating the oral health needs of independently-living older adults in your office. This course is targeted to general dentists to expand their expertise in delivering optimal dental care to this diverse, and growing, senior population who needs care. The course will include patient cases and discussion to assess treatment options based on the patient's goals, ability to pay, health status, etc. The course is designed to build confidence in treating older patients, understand patient care options, and increase access to dental care for older adults.

Marijuana is the most commonly used recreational drug in the United States. Twenty-three states currently have some form of legalized marijuana; eight states have legalized it for recreational use. It is estimated that over 10% of the US population uses it at least once a year.

In addition to marijuana usage, our Nation is experiencing a deadly drug epidemic due to opioid medications being prescribed at an alarming rate. Over 600,000 opioids related prescriptions are written every day in the U.S.

This course will be an unbiased and evidence-based presentation of marijuana, opioids and their role in dentistry.

Course Objectives - As a result of attending this course, you will be able to:

- Review the pharmacology and pharmacokinetics of marijuana and opioids.
- Explain how marijuana and opioid usage by patients effects their oral health; specific focus on oral pathology, caries risk and periodontal disease.
- Recognize interactions of THC with commonly used prescribed medications and be familiar with medical emergencies related to THC.
- Communicate with your patients regularly using cannabis.
- Explore future areas of research in regards to periodontal health, wound healing and caries control.
